Categories of data that are exempted

- Categories of data specific to the internal functioning of the OpusCapita's data processing service where a risk of breach of Opuscapita's trade secrets exists, data and digital assets protected by intellectual property rights of OpusCapita or 3rd parties or constituting trade secrets of the OpusCapita or 3rd party including specifically following:

Data and digital assets relating to OpusCapita's productions platform and applications running or connected to the platform or algorithms, software, technology, conversion programs, settings, knowhow and infrastructure owned, leased, licensed or otherwise used by OpusCapita, its group companies or its subcontractors and vendors to implement, operate, develop and maintain the Services.

- Personal user data will only be provided on a written permit by the customer. Otherwise, personal information from CatalogUser records will be removed before handing over data and address records associated with users as home address (CatalogUser.homeAddressId) will not be provided.
- UserId (CatalogUser.loginName) will not be removed on export even when they contain user email addresses as it is referenced to by other data.
